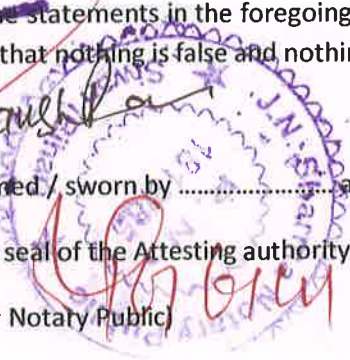



2. The register must be lodged in original with the District Election Officer as the return of Election Expenditure under Section 78 of the Representation of the People Act., 1951. It must be accompanied by an abstract statement of election expenses and supporting affidavit in the prescribed formats. No. return of expenditure will be accepted as complete without the abstract statement of election expenses and the affidavit.

3. Voucher may be not be attached only in respect of those items which are listed in Rule 82(2) of the conduct of Election Rules. 1961 like postage, travel by air. For any voucher not attached vide this rule, an explanation to the affect why it was not practicable to obtain the required vouchers must be given in the prescribed register.

The only exception is the expenses incurred on travel of specified leaders of the political party on account of their travel for propagating the programme of the party. (See Explanation 1 and 2 of Section 77(1) of the Representation of the People Act. 1951.)

4. Each page of the Abstract Statement should be signed by the candidate.
