3. In Part -III, the Lump-sum amount of fund received from the political party or others or the candidate's own funds, should be mentioned date wise. In all such cases such amounts are required to be first deposited in the bank

account of the candidate, opened for election expenses.

4. Each page of the Abstract Statement should be signed by the candidate.
