Madam/Sir,


I am directed to state that Electors Verification program (EVP), is meant for improvement of health of Electoral Rolls and enrollment of all eligible citizens during SSR, 2020 by verification/authentication of electors' details through crowd sourcing and verification through field inputs by BLOs which is scheduled to be launched in all States/UTs on 1st September 2019 as per the approved schedule and detailed instructions/guidelines on activities and rolls and responsibility of each of the officers connected with the revision of electoral rolls have already been issued vide the Commission's letters referred to above.

2. The Commission has decided that in addition to the already approved 7 documents, namely, (i) Indian Passport (ii) Driving License, (iii) Aadhar (iv) Ration card (v) Identity Card for Government/Semi-Government officials (vi) Bank Passbooks, and (vii) Farmer's Identity Card; the following 3 more documents will also be used for authentication of electors' details: -

- (i) PAN Card;
- (ii) Smart Card issued by RGI under NPR; and
- (iii) Latest water/ telephone/ electricity/ gas connection bill for that address, either in the name of the applicant or that of his/her immediate relation like parents etc.


3. The citizens will also be allowed to submit verified documents from Digilocker for which provision has been made on the prescribed digital platforms.
4. CEO will give an e-certificate-cum-appreciation letter to all those electors who furnish information of self and all their family members and authenticate the same. A sample of certificate of appreciation is enclosed herewith.
5. An IT/EVP helpdesk has been established at Nirvachan Sadan, Ashoka Road, New Delhi, with hunting phone lines and other necessary facilities, to assist the CEOs for EVP. This helpdesk will function from 8AM to 9PM, 6 days a week, deploying C-DAC engineers.
6. In case a CEO requires technical assistance in respect of EVP, C-DAC personnel will be deployed in the State as per requirement. CEO may place their requirement in this regard to the IT Division of ECI for necessary action.
7. A dash board has been created to show BLO wise, ERO wise, DEO wise and State wise performance of each of the activities of EVP. The Commission has directed that in order to encourage performance of the officers/officials towards achieving 100% target of the programme, CEO shall issue appreciation letters to 100 BLOs and 50 BLO Supervisors in his State, who are first to achieve 100% target of EVP. Separate scheme for giving incentive to these 100 BLOs and 50 BLO Supervisors will be issued by SVEEP division.
8. Further, appreciation letters will also be issued by the Commission to 25 EROs, 10 DEOs and 3 CEOs, who complete all activities and are first to achieve 100% target of EVP.
