Dear Sir/Madame,

For EVP programme, services of CSC or other citizen service centres are being given access through NVSP for which CEO offices were expected to intimate to ECI. So far such details have been received from Andhra Pradesh, Himachal Pradesh, Orissa, Rajasthan, Andaman Nicobar, Chandigarh, Punjab and Puducherry only. Also for establishing Voter Facilitation Centre at ERO office, the access was decided to be given to officer designate to handle facilitation centres to provide services of verification and authentication to electors visiting ERO Offices. Details of the officer designate for each AC has also expected to submit to ECI, so far such details are received from Himachal Pradesh, Manipur, Chandigarh, Daman and Diu and Puducherry only. All other States are requested to inform the status for both of the above.

For Voter Facilitation Centre, the officer designate will use portal evp.ecinet.in and use their existing credentials at operator level in ERO Net.

For CSCs the State Nodal Officer are to be directed to interact with Mr. Satya at CSC Headquarter in Delhi, who has been provided the necessary API and the process will be initiated by him.

The BEO mobile app will be available for download on apps.mgov.gov.in after 11:00 AM on 1st September, 2019. Only those BEO having their mobile number updated on ERO Net will be able to login successfully in BEO app, after downloading and installing it on their mobile.




