Dear Sir,

Our party is a newly registered unrecognized political party. We have got registration from 8th July 2013. Since we were not prepared to field any candidate in Lok Sabha Election 2014 but it was mandatory to contest election from at least 10% seats of Bihar, we allowed 6 candidates from our party to contest Parliament Election from Bihar in 2014.

We could not pay even single rupees to any of our candidates. All the candidates were directed to meet their expenses from public contributions. They have already given their election expenditure to the election expenditure monitoring officers appointed by Election Commission of India.

In addition to this all 3 persons of our party's star compaigner moved only 2-3 days jointly from their own vehicle in all 6 parliamentary constituency which could not cost more than Rs. 2000-3000 in fuel only.

We have already filled our party's Income Tax Return for 2013-14 on 31.11.2014 positively. A copy of our Income Tax Return has already been sent to Bihar Election Office but we are again attaching herewith.

In our party, only 14-15 persons have contributed. We totally collected Rs. 145006=00 in financial year 2013-14. List of donars are also attached herewith.

Since we could not spent any amount in Lok Sabha election 2014 our party is not required to give any more details of expenditure, despite that we are giving the full information and statement of expenditure in Lok Sabha Election 2014 in the prescribed performa sent by Election Commission of India.
